

# **Ramsey Solutions Teacher Appreciation Giveaway**

## **OFFICIAL RULES**

1. **Who Is Eligible:** To be eligible you must be a legal resident of one of the 50 United States or the District of Columbia, and at least 18 years of age. You must also be employed as a certified teacher teaching a grade level between pre-kindergarten and grade 12 at a public or private high school, middle school, elementary school, pre-school, or equivalent homeschool cooperative. 4. **Entry Period:** Entries will be accepted from April 1, 2021 (12:00 a.m. CT), through April 30, 2021 (11:59 p.m. CT) (“Entry Period”). The Sweepstakes entry form must be completed and submitted during the Entry Period for the Entrant to be qualified to win. Limit one (1) entry per person.
5. **Prize(s):**

- a. **Grand Prize:** Two grand prize winners will each receive \$5,000.00. The winners will receive their prize as a check delivered by mail from Ramsey Solutions or a Ramsey Solutions' selected third party vendor. Prizes will be awarded within four to six weeks after the winners are confirmed.
